### Calculating your fees

- One** Refer to the fees table on page 3. Fees are based on the number of bedspaces at your business. Please note that the fees quoted in this leaflet are exclusive of VAT and that you need to add VAT at the prevailing rate to the total.
- Two** In Year 1 the total payable is the annual participation fee *plus* the one-off joining fee.
- Three** If you apply after the first of July 2009, please see the joining dates chart below.
- Four** Make the most of your business's potential and stand out as a specialist with any of our additional schemes. See page 4 for details and fees for the 'National Accessible Scheme' and the 'Welcome' schemes.

### Joining Dates

We base your participation fee on the time of year that you join the scheme. The year runs from 1 April 2009 to 31 March 2010.

- 1 April to 30 June 2009** If you join between April and June 2009, you need to pay your full joining fee and the full participation fee. You need to pay your participation fee for the next year by 1 April 2010.
- 1 July to 30 September 2009** If you join between July and September 2009, you need to pay your full joining fee and 75% of the participation fee. You need to pay your participation fee for the next year by 1 April 2010.
- 1 October to 31 December 2009** If you join between October and December 2009, you need to pay your full joining fee and 50% of the participation fee. You need to pay your participation fee for the next year by 1 April 2010.
- 1 January to 31 March 2010** If you join between January and March 2010, your participation for this period rolls into the following year so you will need to work out the full participation fee, divide it by 12 and then multiply it by:
  - 15 if you are joining in January and then add the full joining fee;
  - 14 if you are joining in February and then add the full joining fee.
  - 13 if you are joining in March and then add the full joining fee.
 You need to pay your participation fee for the next year by 1 April 2011.

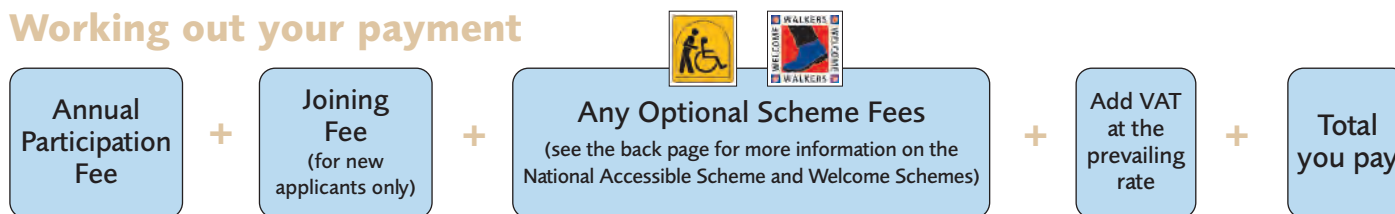

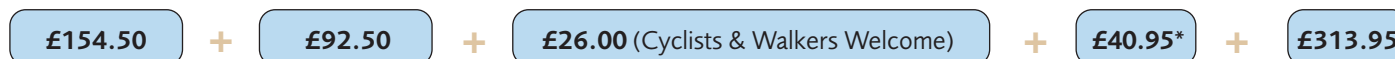
